Filing Deadline: April 1, 2010

1. Applicant must complete application.
2. Applicant must be the primary member of Wyandotte Credit Union.
3. Applicant must be a graduating senior.
4. Please type or print clearly.
5. The following documents must be attached to the application:
 - a. A biographical statement to include:
 - i. Educational background
 - ii. Extracurricular activities
 - iii. Past accomplishments
 - iv. Goals
 - v. Work experience
 - vi. Any other information you believe to be pertinent to this application
 - b. Two (2) character reference letters.
 - i. Letters may be from teachers, employers, coaches or civic or church organizational leaders.
 - ii. Letters may be from other individuals who can personally attest to the quality of your character.
 - iii. Letters from family members will not be accepted.
 - c. Official transcript of courses completed through January, 2010.
 - i. Transcript must include current cumulative GPA.
 - ii. Please convert GPA to a 4.0 scale, if necessary.
6. Your completed application, including all attachments must be received no later than **April 1, 2010**.
 - a. Applicant will be notified of application status during the second week of April, 2010.
 - b. Recipient is requested to attend the Wyandotte Credit Union Annual Meeting (mid-April) for official recognition and presentation of the Wyandotte Credit Union Scholarship.
